

MUNICIPALITY OF CAMPBELL'S BAY - 2015 BUDGET REPORT

February 16, 2015

To the taxpayers of the Municipality of Campbell's Bay:

The 2015 municipal Budget was adopted unanimously by council on December 18, 2014 with a tax increase of \$139. The mill rate remained the same as for the year 2014 which is \$1.13 per \$100/evaluation.

The tax increase is due to the added service for the new potable water treatment plant (water softener).

Not including this new added service rate, there was a slight decrease of \$5 from the 2014 municipal service rates.

Below is a breakdown of the 2015 municipal service rates:

The Municipality had to absorb the impact of the new fiscal agreement between all Quebec municipalities and the Government of Québec. For the year 2015, priority was given to the operation and maintenance of the new potable water treatment plant, restoration of the wastewater management plant, restoration of the Old Pump House in accordance with the Fire Safety Cover Action Plan and renovations to the RA Hall.

The following table shows the general breakdown of the Municipality's revenues and expenditures as budgeted for the financial year 2015.
