OPENING OF THE MEETING IN CAMERA

CONSIDERING the decree number 177-2020 of March 13, 2020, which declared the state of sanitary emergency on all the Quebec territory for an initial period of ten days;

CONSIDERING the subsequent decrees extending this state of emergency, that is, until June 3, 2020;

CONSIDERING the decree number 2020-029 of April 26, 2020, of the Minister of Health and Social Services which allows Council to sit in camera and which authorizes the members to take part, deliberate and vote at a meeting by any means of communication;

WHEREAS according to this same decree, when the law provides that a meeting must be public, it must be publicized as soon as possible by any means allowing the public to know the content of the discussions between the participants and the result of the deliberation of the members;

CONSIDERING that it is in the public interest and to protect the health of the population, of the members of the Council and of the municipal officers that this meeting is held in camera and that the members of the Council and the municipal officers are authorized to attend be present and take part, deliberate and vote at the meeting by videoconference.

THEREFORE, it is moved by Suzanne Dubeau-Pilon and resolved:

That the Council accepts that this meeting be held in camera and that the members of the Council and the municipal officers may participate by videoconference.

ADOPTION OF BYLAW NO 101-2020 - BYLAW REGARDING PROPERTY STANDARDS IN MATTERS OF SANITATION AND NUISANCES IN ORDER TO MAINTAIN PEACE AND ORDER ON THE TERRITORY OF THE MUNICIPALITY OF CAMPBELL'S BAY.

CONSIDERING THAT Article 55 of the Municipal Powers Act allows a Municipality to adopt a By-law in matters of sanitation to determine a property standard, in Order to enforce such standards as well as prescribe fines to persons creating one or several nuisances and to maintain peace and order:

CONSIDERING THAT Article 59 of the Municipal Powers Act allows a Municipality to adopt a By-law in matters of nuisances to determine a property standard, in order to enforce such standards as well as prescribe fines to persons creating One or several nuisances and to maintain peace and order;

CONSIDERING THAT this Council deems it necessary and of public interest to implement a property standards & nuisance By-law;

CONSIDERING THAT a Notice of Motion and presentation of project Bylaw is given on June 5th 2020.

GRADUAL RESUMPTION OF SPORTS ACTIVITIES, PARKS, PLAY STRUCTURES AND WATER PARKS

WHEREAS under decree 2020-041, municipal outdoor play modules, including those for water games can be opened and made accessible to the public, respecting the instructions in force by the Public Health Department, except for group sports such as the ball field and basketball. These are accessible in a "Training" mode only, with no contact, until June 22.

WHEREAS starting from June 22, 2020, group sports such as baseball, soccer, basketball and matches can resume their regular activities.

WHEREAS the municipality wishes to promote hand washing;

WHEREAS access to the toilets at the recreation center will be accessible to the public every day from 10:00 am to 9:00 pm;

WHEREAS regular maintenance of play structures in the park will be maintained;

WHEREAS the municipality has posted instructions concerning the health directives to be followed by government authorities;

WHEREAS Council has taken note of the Quebec Government directives posted on the Quebec.ca website regarding the gradual resumption of activities;

Therefore

Moved by Suzanne Dubeau-Pilon and resolved that the municipality proceed with the opening of municipal parks as of tomorrow, June 19 2020 according to the directives mentioned on the Quebec.ca website section regarding the CVOD-19.
