**ANNEXE A, B AND C OF BYLAW 90-11 – REGULATIONS REGARDING TRANSFER SITE**

**NO CONSTRUCTION MATERIALS ACCEPTED.** RESIDENTS MUST PROCEED TO TOM ORR OR PONTIAC SORTING CENTRE DIRECTLY.

THE TRANSFER SITE IS **AVAILABLE FOR RESIDENTS OF CAMPBELL'S BAY ONLY.** IT IS NOT AVAILABLE TO COMMERCIAL BUSINESSES.

**PROOF OF RESIDENCY IS REQUIRED.** IF PROOF CAN NOT BE PROVIDED, A PROOF OF RESIDENCY TO USE AT THE TRANSFER SITE CAN BE OBTAINED AT THE MUNICIPAL OFFICE.

**EVERY RESIDENT MUST SIGN** THE ARRIVAL SHEET AND DESCRIBE TYPE OF WASTE

**PRODUCTS ACCEPTED:**

- **DOMESTIC WASTE .....\$2 PER BAG (COMMERCIAL OR CONSTRUCTION WASTE IS NOT ACCEPTED - NO ANIMAL CARCASSES ACCEPTED)**

**\*ALL GARBAGE MUST BE IN GARAGE BAGS WEIGHING NO MORE THEN 15 POUNDS EACH**

- **PAPER AND FIBER (NO CHARGE)**
- **PLASTIC (NO CHARGE)**



- **GLASS (NO CHARGE)**
- **METAL (NO CHARGE)**
- **DANGEROUS GOODS - HOUSEHOLD PAINT / USED MOTOR OIL (NO CHARGE)**
- **HOUSEHOLD BATTERIES (NO CHARGE)**
- **FLUORESCENT LIGHTS (NO CHARGE)**
- **TIRES (RIMS REMOVED FOR STEEL BIN) (WE DO NOT ACCEPT TRACTOR OR TRANSPORT TIRES) (NO CHARGE)**
- **ELECTRONICS (NO CHARGE)**
- **TREES, BRANCHES AND LEAVES (NO CHARGE)**

<b>DRESSERS, DESK, KITCHEN TABLE, ETC</b>	<b>\$10 EACH</b>
<b>DESK CHAIRS OR KITCHEN CHAIRS</b>	<b>\$5 EACH</b>
<b>PORCELAIN TOILETS, SINKS</b>	<b>\$15 EACH</b>
<b>KITCHEN APPLIANCES</b>	<b>\$5 EACH</b>
<b>HOT WATER TANKS</b>	<b>\$5 EACH</b>
<b>BBQ'S</b>	<b>\$8 EACH</b>
<b>EMPTY PROPANE TANKS</b>	<b>\$10 EACH</b>
