Under the authority of the Director General of the Municipality, the chosen candidate will have the primary responsibility to provide administrative and accounting support. In addition, the Assistant will accompany the Public Services, Technical Services and Urbanism team in certain administrative tasks.

ADMINISTRATION:

- Provides services to citizens (greet citizens at the counter, answers telephone and emails, mailings);

- Provides administrative support to the Public Services, Technical Services and Urbanism teams;

ACCOUNTING:

- Manages the operations of accounts payable and receivable;
- Manages employee payroll system;
- Ensures the monthly closing activities;
- Ensures the publication of monthly reports on budget variance;
- Ensures the production of government remittances and other government documents;
- Assists in the preparation of external audits.
